CHAPTER E-7.3 REG 2
The Emergency 911 System Act

Title

1 These regulations may be cited as *The Public Safety Answering Point Regulations, 2011*.

Interpretation

2 In these regulations:

(a) “**area of coverage**” means an area served by a public safety answering point by receiving emergency 911 telephone calls placed by connected customers;

(b) “**connected customer**” means a connected customer as defined in *The Sask911 Fees Regulations, 2003*.

3 The following are prescribed as public safety answering points:

(b) Regina Public Safety Answering Point;

(c) Saskatoon Public Safety Answering Point;

(d) Prince Albert Public Safety Answering Point.

Regina Public Safety Answering Point

5 The area of coverage of the Regina Public Safety Answering Point is the area that lies within the boundaries of the City of Regina.

Saskatoon Public Safety Answering Point

6 The area of coverage of the Saskatoon Public Safety Answering Point is the area that lies within the boundaries of the City of Saskatoon.

Prince Albert Public Safety Answering Point

7 The area of coverage of the Prince Albert Public Safety Answering Point is all areas within the boundaries of Saskatchewan that are not included in the areas mentioned in sections 5 and 6.
